

## Sawyer Kensington Trust Minutes

June 8, 2022

In Attendance: Bruce Cilley, Mike Del Sesto, Glenn Greenwood, Janet Bunnell and Selectman Bob Solomon

Meeting called at 5:30 pm at Sawyer Park

**Public Forum:** No one in attendance

**Review of Minutes** 5/11/22 approved with one change (State of MA to State of NH) by motion by Cilley and seconded by Greenwood.

### **Park Update/Maintenance:**

Concession stand to be inspected for fire suppression on June 10.

Discussed making a new sign about dog regulations because adherence is not being followed.

Water testing on 6/7 was completed.

Irrigation leaks to be fixed week of 6/11.

### **Bills and Financials:**

Two invoices totaling \$1,266.83 (field \$520.73 and park \$754.10) from Until were reviewed and approved. Motion by Greenwood, seconded by Bunnell.

Down to Earth invoice for \$12819 was approved by motion by Greenwood, seconded by Bunnell.

April and May bathroom cleaning invoice for \$\$3,520 was approved by motion by Greenwood and seconded by Del Sesto.

Total Income: \$14,225. Breakdown is \$6,995 from Alnoba Art Walks in March, April, and May 2022, and \$7,230 in user fees (\$5,600 from New Balance and the remainder from birthday party rentals).

Checking Account Balance: \$182,166.96

Tax Preparation and Submission completed. \$720 payment was approved on motion from Greenwood, seconded by Bunnell.

### **Old Business:**

Park Manager –Allie Levesque recommendation to hire needs to be approved by Mr. Lewis and will be addressed when he returns from Europe.

### **Park Schedule Update:**

KYAA Representative did not attend meeting.

KYAA has notified the Trust that they gave Exeter EBJL baseball some of the dates they secured and requested additional dates that they pulled back from.

Request for rental for a birthday party on 8/14 from 1 to 3 p.m. was approved. Motion by Bunnell, seconded by Greenwood.

Road race has been planned for 8/13 to be stationed at the Park and ending at the park beginning at 9:00 a.m.

**New Business:**

Request made by Courtney Preneta, Conservation Committee and Kensington Trail Committee, to drive a tractor over Park Property to build a bridge on Trundlebed Trail.

The Trustees walked the trail and voted to not allow wheeled vehicles on the trail that is on park property due to the fear of the damage wheeled vehicles to the existing trails, exposed roots of the trees and bridges that need repairs.
