Park Update/Maintenance: Allied Clearwater on 3/23 to chlorinate well for State inspection.

SKT Monthly Accounting, Bills and Financials:

Profit and Loss through 3/7 reviewed.

- Checkbook balance \$157,889.85
- Bills All following bills motion to approve by Bunnell, seconded by Greenwood. Passed unanimously.
 - o Two Until invoices totaling \$257.00 (field \$101.46 and park \$155.54)

Old Business:

- Pickleball Courts Del Sesto plans to meet Landscape Design at the Park for cost estimate.
- Website Edits to the new website were provided by the Trustees and will be sent to GoDaddy for updating.
- Exeter Junior Baseball League (EJBL) and Kensington Youth Athletic Association (KYAA)
 - o Patrick Flaherty shared a quote received to move three sprinklers \$100 to make Field B convertible and consistent with Field C.
 - o A quote received by Dan Provost for materials totaled \$1,400. He made a request to order materials.
 - o Additional work may be needed and the total cost by be \$2,500. EBJL will pay the upfront cost.
 - o A 50% deposit payment will be sent, insurance coverage, and the schedule for all games dates and times that includes all Kensington player teams.
 - O Motion to allow Field B to be convertible to accommodate 11–12-year-olds, and up to \$2,500 in cost to be negotiated against the EBJL field fees, except for the light fees made by Greenwood, seconded by Bunnell. Passed unanimously.

New Business:

 - EBJL conflict on one date requested on May 6, ask to possibly move because of parking issues. Bob Solomon will ask the town for permission to park on one side of the street and we will encourage EBJL to park on one side of the street. Motion to accept EBJL Schedule by Greenwood, seconded by Cilley. Passed unanimously.
 - o Granite State Baseball's request for 15 dates approved with one date (May 2 due to a conflict) by Greenwood motion, seconded by Cilley. Passed unanimously.
 - o Mary Larson, Regeneration Church application for June 4. We will inform her the date is not available.
 - One Sky application for 7/15 for 200 to 300 people and 150 cars discussed. The pricing for oversight will be sent to One Sky by Donna Carter. Donna will request that One Sky attend the 4/12/23 meeting to discuss their plans further with the Trustees.
