April 12, 2023

Meeting called to order: at 6:00 p.m. at Sawyer Park. Public Forum: Janan Archibald, Bob Solomon, Martin Lawrence in attendance.

Review of Minutes: 3/13/23 minutes reviewed and approved with two edits by Carter, seconded by Cilley.

Park Update/Maintenance: 4/17 water sample, bathrooms cleaned, soap and toilet paper stocked. Urinal flow monitor in men's bathroom will be replaced. Spring cleaning completed. Mulching will be completed by 5/15. The cracked tree on Trundlebed Lane was discussed. If it falls, it will take down wires. Bob Solomon agreed to inquire with the town about cutting it.

- One Sky via Janan Archibald attended the meeting to discuss their 7/15 plans further with the Trustees. The parking issue was discussed. The request for parking spaces is twice what we have. Motion to approve working with the applicant to obtain police detail, discuss placement of bouncy houses, and food truck by Greenwood, seconded by Cilley. Passed Unanimously.

New Business:

 - CMS Sunshine Committee application for Pavilion, an alcohol permit, and 100 people in attendance on 6/1 from 3:00 p.m. to 6:30 p.m. Motion to approve based upon an alcohol permit provided by the Board of Selectmen and a discussion with the police requiring a police detail.
